OLD BUSINESS:

- 1. Bank Change: Denny thanked Ken Rausch for going to the bank with him. Ken became the primary person on the account. He appointed Sara Bacon as administrator. The two signatures are Cathy Gildner and Ken Rausch. The new bank is Launch Credit Union. We have to buy our own checks, as Launch does not have two-party checks.

Ken Rausch agreed with Gregg and ask that management sit down with the Board. Tom White agreed we should email Sheri Woodworth with all the information we have. John Meyer thought we should invite Sheri Woodworth to an HOA meeting. Terragone Engineering said the schedule is up to Sun

Communities. Denny told the Terragone engineer that the community is full of rumors. The engineer (John) said he would contact the directors over Tiffany and let them know that a resident contacted them to see what the schedule was. Denny suggested he contact Sheri Woodworth or Amy Herndon. John said he would get with Amy. Denny asked if Ken Rausch would make a motion to have Denny send an email to Sheri Woodworth, requesting a meeting with her to discuss the apparent misinformation we have been receiving and also inviting her an HOA meeting and include in that email correspondence from Kristin and the correspondence from the unknown resident. Dick Wood seconded. Denny didn't think the letter from the unknown resident should be included. He also didn't think their notes from their monthly meetings with Tiffany should be included. Gregg Allen didn't feel that information should be included. He does want to put together a timeline of the pier situation. Tom White didn't think it would do any harm to include the letter from the resident. Denny felt it was part of the picture. Ken Rausch thought we should send it to her. Ken amended the motion to remove sending the correspondence from the unknown resident. A new motion was made to send an email to Sheri to discuss the apparent misinformation we've been receiving and invite her to an HOA meeting and a meeting with the Board. Dick seconded the motion. The motion carried 5-1.
