## MONTHLY MEETING MARCH 4, 2025 CLUB RIO HOMEOWNERS ASSOCIATION, INC.

**CALL MEETING TO ORDER:** Meeting called to order at 6.00pm by President Denny Jameson.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Led by Denny Jameson.

REMARKS BY TIFFANY: Tiffany advised the residents that the paper towel dispensers in the restrooms have been replaced with hand dryers. There will be a Health Fair on April19th, which will be held in conjunction with Fun Day. There are 13 houses on order for the expansion. She will be doing home inspections, looking for the following: a clean house, does it need painted, is there clutter and are there weeds? There is a current audio/visual IT issue, for which she's requested Sun's help. She stated that she's perfectly fine with the residents doing some fact checking. There have been no permits requested or issued by the City of Edgewater. None will be issued until the work commences. Permits have an expiration date. They do not have a contract with Cove Point and won't until work starts. Cove Point is taking care of the docks, not the piers. Sun is making the boat ramp as accessible as possible without putting the workers in danger. They do not have a set date for starting the work. Supplies are no longer an issue.

**<u>GUEST SPEAKER:</u>** Eric Rainbird, candidate for City Council, gave his vision for the community and asked for your vote.
