# MONTHLY HOMEOWNERS' MEETING OCTOBER 7, 2025 CLUB RIO HOMEOWNERS' ASSOCIATION, INC.

**CALL MEETING TO ORDER:** Meeting called to order at 6.00pm by President Denny Jameson.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Led by Denny Jameson.

**ROLL CALL:** Present were President Denny Jameson, 1<sup>st</sup> Vice President Tom White, 2<sup>nd</sup> Vice President Cathy Gildner, Directors Gregg Allen, Bob Karvonen, Ken Rausch, and Dick Wood. Treasurer Sara Bacon and Recording Secretary Linda Bennett were absent.

**OPEN FORUM:** Kristin Piatt, Sr. Community Mgr., was present at an Open Forum. Topics discussed were the Ad Valorem tax, pond algae, Club Rio driveway tree roots, storm drains, long run for dog park, pier construction, use of jacuzzi, lights at Club Lago, Sales Team moved to Club Rio, (Denny's question?), flags out front, additional lighting at North gate, boat yard road, and the pedestrian gate. Kristin stated mangrove trimming and algae treatment of the ponds would be starting tomorrow. Anytime you have questions, feel free to contact her.

<u>APPROVAL OF SEPTEMBER 2, 2025 HOA Minutes:</u> Ron Von Rapacki made a motion to accept the minutes, seconded by Tish Michelson. There was no discussion. The motion carried.

<u>TREASURER'S REPORT APPROVAL:</u> In the absence of Treasurer Sara Bacon, Denny reviewed the Treasurer's and Budget reports. John Meyer made a motion to accept the reports, seconded by Lynn Surowich. There was no discussion. The motion carried.

**RESIDENT'S COMMENTS OR QUESTIONS:** Cheryl Davis is against the BOD paying for Laura Grogan's travel expenses, to serve as Social Committee Chairperson, once she moves to CT. Her suggestion was that one or two members take over that position.

# **COMMITTEE REPORTS:**

Homeowner's Committee (HOC): Denny reported that HOC and BOD met with Sun, last Tuesday, to discuss some changes they want to make in the Prospectus and the Rules and Regulations. On Thursday, the HOC and Sun will meet concerning the rent and the Ad Valorem tax. Thursday's meeting will be the first of two meetings which are required, per FS-723, to discuss the rent issue. They will tell us no to not raising the rent. We will have a second meeting, where they will also tell us no. The BOD has discussed considering filing a lawsuit for breach of contract and reduction of service because of the pier issue. Our attorney, in the past, has told us, if we file a lawsuit, we have to be able to put a figure on, based on some logic, how long the piers were down. Those piers have been down since March 2024 and based on the time the contractor said it will take to fix the piers, it will be every bit of two years. Our contention would be that they did not act in due diligence. Just because we file a suit, doesn't mean that we can go through thousands and thousands of dollars. Once the suit is filed, if that's the decision, we will try to get the media involved. It's another black eye on Sun. Fred Neiswenter stated he felt it was a losing proposition on the docks. The hot tubs, swimming pools, potholes, and docks, was a waste of time trying to get down times. Denny stated he spoke to our attorney about those issues. We have to have documentation regarding when they were down. We do have documentation on the piers. Our attorney has been copied on all emails regarding these issues.

<u>Welcome New Homeowners' Committee:</u> Sue White had no report. Someone had asked a question about how many homes were here. Denny reported there were 732 homes. There will be 803 homes.

<u>Membership Committee:</u> Denny stated we have 204 paid members. Members in the audience asked about raising the HOA dues. Denny said the BOD would take it under advisement.

<u>FMO:</u> Ken Rausch stated, in the past, he had given the many reasons for joining the FMO and thanked those who did. He said that the FMO is the only organization that represents the homeowners at the state legislature. The next FMO meeting will be held at Hacienda, and he will give the details in the Newsletter. There is no charge to attend the meeting and all residents may attend. The cost to join the FMO is only \$40 per year. See him for applications or see our website or the FMO website.

**Social Committee:** In Laura Grogan's absence, John Meyer thanked everyone who attended the 70's Disco Party. They sold 102 tickets. The Social Committee met last week and mapped out some parties for next year. They're still in need of people to host these parties. The next meeting is November 6, at 6:30pm at Club Lago. That's the Florida law that governs the relationship between people like Sun Communities and us. Also read .61(B)-31(4). Our attorney is telling us that the Prospectus follows what was in effect when you bought your home. The Ad Valorem tax does not apply to us. Sun also wants to charge the residents for community trees that need to be trimmed. The HOC is trying to fight these changes. Denny also stated that he isn't going to resign his position after his term is up. However, he does not intend to run for re-election.
